# **Taronga Conservation Society Australia**

Taronga Conservation Society Australia (Taronga) operates Taronga Zoo in Sydney and Taronga Western Plains Zoo in Dubbo. Taronga is a leader in the fields of conservation, research and environmental education.

Taronga is constituted under the Zoological Parks Board Act 1973 as a statutory authority owned by the people of New South Wales (NSW) and administered by the Minister for the Environment and Heritage. Amended legislation in 1992 defined Taronga's responsibilities in education, conservation, research and recreation. A minor amendment to the Act was undertaken in 2008 to formally recognize Taronga Conservation Society Australia as the official name, to better describe the work of the organisation.

# **Brief History**

Taronga Zoo was officially opened in October 1916, displaying animals brought from the Moore Park Zoo which was originally founded by the NSW Zoological Society in 1881.

The new Zoo was administered by the Taronga Zoological Park Trust consisting of 12 members acting in an honorary capacity, most of whom were Royal Zoological Society councillors. This was replaced in 1973 by the Zoological Parks Board of NSW, constituted under the *Zoological Parks Board Act 1973* and given defined responsibilities in education, conservation, research and recreation.

Taronga's sister zoo, Taronga Western Plains Zoo, opened in February 1977, fulfilling a need for an open-range facility for displaying mainly grazing animals and providing additional space for the breeding of endangered species.

The two Zoos complement each other in achieving Taronga's goals. Taronga also maintains a close association with other wildlife organisations including the International Rhino Foundation, of which Taronga is a founding Board member, the World Association of Zoos and Aquaria (WAZA), International Union for the Conservation of Nature (in particular their Captive Breeding Specialist Group), the Zoo and Aquarium Association (ZAA), as well as universities and research organisations throughout Australia and overseas.

Both Taronga Zoo, Mosman, and Taronga Western Plains Zoo, Dubbo, are open to the public every day of the year during the hours 9:30 am to 4:30 pm (Taronga Zoo) and 9am to 4pm (Taronga Western Plains Zoo).

## **Composition of the Board**

Appointment to the Board is governed by Section 6 of the *Zoological Parks Board Act* 1973, which provides:

- **6.(1)** The Board shall consist of 10 members of whom:.
  - (a) five are to be persons who have, in the opinion of the Minister, qualifications, knowledge, expertise or experience appropriate to the powers, authorities, duties and functions of the Board, and



- (b) one is to be a person who has, in the opinion of the Minister, expertise in zoology, veterinary science, animal welfare, or in research relating to any one or more of those fields, and
- one is to be chosen by the Minister from a panel of 2 persons nominated by an organisation determined by the Minister, the principal activity of which is the voluntary provision of financial or other support to the zoological park in Sydney, and
- (d) one is to be chosen by the Minister from a panel of 2 persons nominated by an organisation determined by the Minister, the principal activity of which is the voluntary provision of financial or other support to the zoological park in Dubbo, and
- (e) one is to be chosen by the Minister from a panel of 2 persons nominated by the Mosman Municipal Council, and
- one is to be a person chosen by the Minister from a panel of 2 persons nominated by Dubbo Council

# **Functions of Taronga**

The main functions of Taronga are specified in Section 15 of the *Zoological Parks Board Act 1973* which provides as follows:

- **15 (1)** (Taronga) may establish, maintain and control zoological parks for the following purposes:
  - (a) carrying out research and breeding programs for the preservation of endangered species;
  - (b) carrying out research programs for the conservation and management of other species;
  - conducting public education and awareness programs about species conservation and management;
  - (d) displaying animals for educational, cultural and recreational purposes.
- (2) (Taronga) may also maintain and control:
  - the zoological park established before the commencement of this Act on the land described in Schedules 3 and 4, under the name of "Taronga Zoological Park"; and
  - (b) other zoological parks on land or premises vested in or held by the Board, whether or not those parks were established by the Board,

for the purposes referred to in this section.

**(3)** (Taronga):



- (a) may co-operate with, and provide funds and other assistance to, such scientific and other institutions, governments and other bodies and individuals as Taronga may determine in connection with species conservation and management and for other scientific and zoological purposes: and
- **(b)** may investigate and carry out research into:
  - (i) the design of, and equipment and procedures in zoological parks; and
  - (ii) the care and well-being of animals kept in zoological parks,

whether or not those zoological parks are maintained and controlled by Taronga; and

- (c) may provide educational services for the public, (whether in the nature of lectures, broadcasts, films, publications or otherwise) about species conservation and management, zoological parks and the biology of animals; and
- (d) may provide and charge for such services in connection with zoological parks maintained and controlled by Taronga as Taronga may determine; and
- (e) may make recommendations or reports to the Minister with respect to matters connected with the Board's powers, authorities, duties and functions or the administration of this Act.
- (4) The Minister may request the Board to make recommendations or reports to the Minister with respect to matters connected with Board's powers, authorities, duties and functions or the administration of this Act and the Board is to comply with any such request.
- (5) The Board may exercise and perform such other powers, authorities, duties and functions as may be conferred or imposed on the Board or under this or any other Act.

# **Taronga's Strategic Focus Areas**

Taronga's corporate goals and key objectives are defined in a five year Strategic Plan and consist of the following:

- Conservation Outcomes actively participate in wildlife conservation initiatives that ensure the long term security of wildlife in sustainable ecosystems and habitats
- 2. **Wildlife in our Care** Be a leader in the care and presentation of wildlife, providing positive welfare, dignity and respect for all



- 3. **Transformational Guest Experiences** Attract an increasing number of guests to our Zoos and inspire action through experiences that increase knowledge and change people's attitudes and behaviours
- 4. **Excellence in Conservation Education** Increase participation and inspire action for the wild through innovative and authentic education programs
- 5. **Engage and Influence** Engage, grow and mobilise our members, supporters and networks to achieve positive outcomes for wildlife

# **Public Participation in Policy Formulation**

Public participation in the formulation of policies of the Taronga Conservation Society Australia takes place as a result of the composition of Taronga's Board which includes representatives of the community, local government and volunteers. The Board meets on a bi-monthly basis.

Taronga welcomes public comment and regularly conducts visitor feedback surveys as well as receives suggestions and feedback via Taronga volunteers who work directly with visitors. As well, the telephone switchboard staff on a daily basis assist with questions from the public. The Guest Services Division receives and responds to hundreds of letters every year most of which include suggestions from the public on how to improve our services. These all contribute to policy formulation or policy amendment.

# Information held by Taronga

As an organisation committed to a shared future for people and wildlife including the promotion of positive community attitudes towards wildlife and the environment, Taronga holds, processes and produces a large amount of information, including publications which are available on our website - https://taronga.org.au/about/publications

Major categories of information are:

- Documents created by Taronga for public information about wildlife and conservation such as magazines, brochures, newsletters, policies, scientific, technical and research material, maps and plans and documents relating to the internal administration of the agency.
- Documents provided to Taronga by members of the public, Government, agencies, businesses, community organisations including conservation partners and other third parties
- Information held in electronic, digital, visual and audio form, photographs, CDs, DVDs and audio recordings.

# **How to Access our Information**

In accordance with the GIPA Act, Taronga provides public access to its information in various ways.



## **Open Access Information**

Open access to information has been provided on our Taronga website (<a href="www.taronga.org.au">www.taronga.org.au</a>). This includes information that Taronga is required to make publicly available under the GIPA Act such as:

- Policy documents
- Information released under the GIPA Act (the GIPA Disclosure Log)
- The register of contracts valued at \$150,000 or more
- Annual Report
- This Information Guide

### Proactive release of information

Taronga proactively releases a wide range of information via its website. This includes information about:

- Animals including research and conservation programs Taronga is involved with
- Visiting our sites
- Our education programs
- Volunteering at Taronga
- Our major capital programs
- Our history.

#### Informal release of information

We also assist the public with informal requests via telephone, email and mail. Where appropriate, Taronga provides information on an informal basis to lessen the need for formal GIPA access applications.

### Formal release of information

### **Excluded Information**

Taronga may be required to refuse access to information where there is an overriding public interest against disclosure. This can include information that:

- Is confidential
- Would breach privacy obligations
- Would undermine Taronga's competitive neutrality where it competes with other businesses
- Would prejudice any person's business, commercial, professional or financial interests
- That could jeopardise public safety, law enforcement or the fair trial of a person.
- Would prejudice the effective exercise by Taronga of its functions.



Taronga must not disclose certain categories of information noted in the GIPA Act Schedule 1 including information that:

- is subject to overriding secrecy laws
- relates to Cabinet deliberations or decisions,
- relates to Executive Council deliberations or decisions
- is subject to client legal privilege

### **Review of decision**

If you are not happy with a decision made formally under the GIPA Act, you have rights of review both internally within Taronga and externally. Information about these rights will be provided in response to your formal application.

The following application fees and charges apply to GIPA applications:

# **Discounts**

Discounts of 50 per cent on processing charges (not application fee) may be available on fees and charges:

- For holders of a Pensioner Concession card issued by the Commonwealth
- For non-profit organisations
- For a full-time student
